# HWC/24/020 Minutes Council Meeting held 8th April 2024

a. To approve and sign the minutes of the meeting 8<sup>th</sup> April 2024

These were agreed to be a true record of the meeting and were signed by the Chair.

c. To deal with any correspondence

The Hampshire Police Cyber crime unit proposed undertaking cyber fraud awareness sessions for the community. The Clerk was asked to investigate and to work with Kings Worthy PC if appropriate.

#### HWC/24/021 City and County Councillor Reports

Cllr Porter's report had been circulated before the meeting. She said she had written to HCC countryside service regarding Nun's Walk (HWC/24/006i). She had suggested making the route wide enough for cyclists. She said that WCC were undertaking a peer review and she had put forward HWPC as an



appropriate PC for WCC to approach. She recognised that governance was an issue for HWPC and suggested that the PC write to the Chief Exec Officer at HWPC to ask that the issues addressed in the Internal auditor's report (C/24/011a) could be addressed by WCC. The Committee agreed to refer this to the next HWPC meeting.

#### HWC/24/021 M3 Jnct 9

a. Note the decision and any actions/meetings that need to be taken
The decision, been taken by the Secretary of State that the project would proceed, was noted.

# b. Cart and Horses junction

Cllr Porter said that HCC was disappointed that the decision (HWC/24/021a) had not included work to the Cart and Horses junction. She said that HCC would be negotiating regarding funding which may include Kings Worthy CIL money. She said the public consultation favoured 2 roundabouts.

#### HWC/24/022 Down Farm Lane Improvements

The proposal from HCC to install ATMs on Down Farm Lane to collect information on the traffic and speeds of vehicles, which was required by HCC in order to take any traffic calming measure forward, had been circulated before the meeting. The Clerk commented that she had been unable to ascertain from WCC if CIL money could be used. Mr Gibson queried the placement of the ATMs if the intention was to catch the optimum speed data. Cllr Hamblin said he would be interested in the data on the use of the road by sat nav drivers. The Committee voted unanimously to agree to HCC's proposal. The Clerk was asked to clarify what information the ATM's would collect.

#### **HWC/23/023** Community Resilience – Flood Alleviation

#### a. Update on HCC's alleviation plans

It was confirmed that the Gas pipe line that obscured the ditch in Springvale Rd had now been removed. Mr Gibson said the removal of the pipe would reduce the build up of silt. A weir kerb had been installed so no further works were expected from HCC.

# b. Removal of lining at Worthy Barn

A meeting was due to be held in July with the owner of Worthy Barn, HCC's John Dimond, Mr Gibson and the Clerk. The owner of Worthy Barn was due to investigate the width of the concrete lining in order to inform how it could be removed. It was likely that a FRAPP licence would be required. Mr Gibson commented that HCC had modelled the flooding in the area and had determined that this ditch created a pinch point.

c. Development of plans for historic pipe that removed flood water This had not been progressed.

#### HWC/23/024 The Dell

a. Repairs to the basket swing and the re-siting of the climbing frame. The Committee agreed to the quotation by Infinity Playgrounds for the resiting of the climbing frame at a cost of £3655.92. The works had now been completed although the new slide was not yet available to be installed.



Access to the slide had been closed off but the climbing frame was in use. The repair to the basket swing had been completed.

The Clerk explained that the reports had been late and in the case of Greenfields had contained inaccuracies. She said it was imperative that the reports should be reliable. Two quotations from alternative suppliers had been circulated before the meeting. It was agreed unanimously to change the supplier for the Dell Inspections to Infinity playgrounds.

#### HWC/24/025 Upgrade of Nuns Walk

#### a. Update on the plans for improvements

It was agreed HCC would need to endorse the scope of the project before it could be taken further. It was agreed to focus on the damaged area that bordered with HIWWT Nature Reserve. Cllr Porter commented that a number of licences would be required. Ms Welland said a tender document was required to establish what work was needed to be done. She said it was likely that technical expertise would be required. It was acknowledged that the owner of the adjacent field would need to be approached for access. The Clerk said it was unregistered. She was asked to enquire, from the new owners of the farmhouse, who she should approach. Cllr Porter agreed to go back to HCC Countryside manager for his input.

They had grants available for the purchase of equipment for volunteers to do the work under the guidance of the PC. Cllr Porter commented that other Councils had brought a brushcutter between them.

The Clerk said that registering all the routes as ROW may be problematic because the Diocese had already made their objection known regarding the route to Springvale Rd (C/22/070). She said it would be better to focus on the route from the Dell to Mount Pleasant because there was no registered owner of the land. This was agreed.
