C/23/035 To Resolve the acceptance of the agreement reached by WCC and CALA

regarding the commuted sum for the maintenance of the open spaces

due to be handed over to HWPC.

The agreement reached by WCC and CALA had been circulated to the Cllrs before the meeting. The Clerk explained that the Council needed to resolve to accept the commuted sum as set out in the terms of the agreement between CALA and WCC. She noted to the Council that KBC had recommended to HWPC that it was accepted (KB/23/032). Cllr Rutter explained that the agreement that had been circulated would form the legal agreement between the two parties. Cllr Watters commented that the sum was disappointing and the maintenance of the open spaces would need higher contributions from the precept. The Council resolved unanimously to accept the agreement on the commuted sum as laid out in an email from WCC's Mr Steve Lincoln, dated 11th May 2023.

The Council agreed to accept the legal transfer of the two pieces of land to the ownership of Headbourne Worthy Parish Council with the commuted sum agreed in C/23/035. This resolution was unanimous.

- ii The Council agreed to undertake the maintenance of the area that was in St. Barnabas ward if requested by WCC and/or St. Barnabas ward on the understanding that HWPC would be paid a sum agreed with WCC and/or St Barnabas Ward for this work. This resolution was unanimous.
- In the unlikely event that HWPC was asked to take on this land the Council agreed for the legal transfer of this land. This resolution was unanimous.
