KB/25/060 Apologies

KB/25/063 Approve Minutes of Meeting of 21st July 2025

a. To approve and sign the minutes of 21st July 2025

The minutes were agreed as a true record of the meeting and were signed by the Chair.

b. To deal with matters arising not on the agenda.

The Clerk asked for the Committee for a new name the 2A MUGA playground. Mr P Turner agreed to ask KBRA.

c. To deal with any correspondence

There had been 2 occasions over the summer when the temporary traffic lights on Winchester Ave had not been working. CALA had admitted that the battery had not been sufficiently charged and had agreed to pay this more attention.



KB/25/064 <u>City and County Cllrs – matters that need to be brought to the Committee's attention</u>

Cllr Porter said that she, Cllr Tod and Cllr Warwick had met with HCC concerning the proposed junction of Andover Rd, Winchester Ave and Harestock Rd. They had expressed concern of the likelihood for bad parking around the proposed 1b park. HCC had confirmed that the barriers placed at Andover Rd would be concreted heavy duty barriers.

a. Update on WCC's CGR for Winchester "Town" Council

Cllr Cramoysan confirmed that Kings Barton residents would be asked if they wanted to join Winchester Town, stay with Headbourne Worthy or become their own Parish. He said that residents in St Barnabas Ward would be asked if they wanted to stay as they were and become part of Winchester Town or join the rest of Kings Barton. He confirmed that Headbourne Worthy village would also be asked if they wanted to remain with Kings Barton. They would not have the option of joining Winchester Town. Cllr Porter said there would be a consultation process running from mid-October to mid-December to which residents and the Parish Council would be asked to respond. This would be followed by a second consultation in the Spring which would deal with any queries from the 1st. Therefore, if Kings Barton residents expressed a wish to stay with Headbourne Worthy or to become its own Council, the issue of the number of Councillors would be addressed then.

The Chair moved item 11 up the agenda

KB/25/066 Community Building

a. Update on the Trustee recruitment

Cilr Turner confirmed he had contacted the residents that had expressed an interest in becoming the CIO trustees. He said that only 2 had responded positively and therefore, with himself, they had the minimum number of 3 trustees. It was suggested that Cllrs could become trustees until others came forward.

b. Consider budget or setting up building

The Clerk asked the Committee to consider what funding was needed to start the building operating and what materials would be required. She said it would be possible for the Council to buy the materials before the building was transferred to the CIO and that the Council could agree to lend the CIO money. It would not be possible to grant the CIO a substantial amount. It was agreed to investigate how much commuted sum would be part of the transfer. Cllrs Cramoysan and Porter suggested writing a business plan and that Action Hampshire would be able to help with this. The Committee agreed to set up a WG to prepare a business plan and consider what needed to be thought about. Mr P Turner agreed to reach out to KBRA for membership of the WG.

KB/25/067 CALA

Matters for the meeting Agenda between HWPC and CALA Cllr De Stefano expressed cynicism that it was worth continuing with these



meetings. He said that CALA had a track record with not engaging and he pointed out that the PC had written to CALA regarding the road works but had not received a reply. Cllr Watters felt that it was important to continue with them because it kept communication channels open and gave Ms Thompson a steer on the other things that were happening. The Committee agreed to continue and with the agenda proposed. Cllr Cramoysan said that the lack of response from CALA could be brought up at the KB Forum.

b. New Streetlights in Winchester Avenue.

A resident had contacted HWPC and KBRA regarding the new LED lights that were very bright into his home. Cllr Porter had got an agreement from HCC that louvres could be fitted and had asked CALA to install them. Cllr Watters said that CALA had now installed streetlights on Kohsla Rd and Morse Rd. He queried why the streetlights had not been restricted to Winchester Ave. Cllr Porter said she would look into the matter.

c. Large MUGA - letter from WCC to CALA

There was no confirmation that this letter had been sent. Cllrs Cramoysan and Porter agreed to investigate.

KB/25/068 Meadowside Park

a. Update on handover to HWPC

The Clerk had spoken with Mr P Farrell. He had confirmed that CALA was aiming to lift the matting and install the turf in the next 2 weeks. The Clerk would arrange for an inspection after that. She had commented to Mr Farrell that the gate needed repairs.
