HWC/25/030 Apologies

Apologies were received from Cllr Hamblin, Ms MacCaul and Ms Welland.

HWC/25/031 To receive declarations of pecuniary interests (DPIs) and other significant interests from members concerning specific items on the agenda Cllr Wilson declared an interest in planning application 25/01890/HOU.

HWC/25/032 **Public Participation**

One member of the public showed the Committee the plans for padel courts at the Winchester Golf academy for which application 25/01799/LDC was relevant. He said the expectation was that 4 courts would be installed. Other members of the public agreed to wait until the agenda item they were interested in was reached

HWC/25/033 Minutes of HW Committee Meeting held 14th July 2025

- To approve and sign the minutes of the meeting 14th July 2025 These were agreed to be a true record of the meeting and were signed by the Chair.
- b. To deal with matters arising not on the agenda
 - The theft of copper cable was noted. The landowner said this had now been replaced by the suppliers.

HWC/25/034 City and County Cllr reports

i Cllr Cramovsan confirmed that the food waste collection service was now operational in parts of WCC but would be rolled out per postcode.



ii Cllr Porter said her Council grants had been restored, but not up to the same level. She said that a lot of her time was being spent on TROs for Welhouse Lane. She raised the planning applications for industrial units at Popham logistics and said that HW was likely to be affected. She said that WCC was 96% on target for carbon footprint reduction. She said the Local Plan was now on track for its final consultation which meant it would be finalised in the Spring. This meant that WCC was now required to commence the next Local Plan and there was now a new call for sites. She said that previous sites that had been submitted would need to be re-submitted.

HWC/25/35 Winchester Town CGR

Cllr Cramoysan said he had lobbied to change the ToRs for the CGR. He said that there were now 3 questions to be considered, whether Kings Barton wanted to become part of Winchester Town remain with HWPC or be independent. He said the question of the number of Cllrs would be dealt with in the second consultation. The question of the viability of a standalone Headbourne Parish was raised with the consideration that a smaller parish may have a small precept but if shared with a small number of people it makes a for a high individual contribution. The Clerk said that in other parts of the UK where, unitaries had been introduced, the responsibilities of a PC increased.

HWC/25/036 Down Farm Lane Improvements

a. Agree position of proposed modal filter for traffic calming measures
The Clerk had circulated a map showing the positioning of the modal filter
close to the entrance of the road to the A34 underpass, as proposed by the
Committee (HWC/25/021a). She said that HCC was open to the installation
of the filter in this position. A member of the public was very supportive of
the proposal. He said he did not anticipate it would affect the businesses
the other side of the A34 underpass. The other member of the public was
also supportive. It was recognised that if the filter was installed by the
railway bridge then there would be issues with vehicles attempting to
reverse. The Committee agreed the importance of appropriate warning
signs. A proposal to have two filters at either end of the road was rejected.
Cllr Porter said that improvements to the Welhouse Lane junction with
Andover Rd would encourage drivers to use this junction. A member of the
public asked about funding and said he would be prepared to make a
contribution.

The licenses from the EA would need to be applied for in the meantime. An HCC officer had notified the Clerk that a resident had requested a diversion of the path. As the diversion was outside the HW Parish boundary the Committee made no comment.

It was noted that the path may lie on land owned by HCC and that residents had complained about the slippery surface. Cllr Wilson said he would approach the Church.
